- 2. The engagement shall be initially for a period of 01 year which can be extended or curtailed as per the requirement and satisfactory performance.
- 3. The terms of engagement on contract basis shall be upto 65 years of age for all contractual posts but in case of Consultant (Finance & Accounts) the same can be extended upto 70 years of age on year to year basis as per the requirement & satisfactory performance.

- 4. The upper age of the candidate shall not be more than 64 years as on closing date of receipt of application.
- 5. The selected candidates are liable to be posted in National Bal Bhavan, Kotla Road, New Delhi and JBB, Mandi, New Delhi .
- 6. The normal office hours will be 09:00 A.M. to 05:30 P.M. from Wednesday to Sunday. The Monday & Tuesday will be weekly closed days. All Gazetted Holidays will be applicable to the contractual staff. In the exigencies of work, the contractual staff can also be called for duty on holidays and after normal office hours.
- 7. Staff to be engaged to contractual positions will be provided 08 days Casual Leaves and 02 days RH.
- 8. The continuity of service in National Bal Bhavan is subject to satisfactorily performance and requirement of the contractual staff. The services of the contractual staff shall be terminated by the National Bal Bhavan without any prior notice and same shall be replaced by M/s New Tiger Security Services by forwarding the name of suitable candidates for the post.
